**\*BACKFLOW DEVICES** – A backflow device is a device or means designed to prevent backflow or back siphonage.

- ALL Commercial and Industrial Customers are required, according to regulation, to have one or more backflow prevention devices installed and shall assume the responsibilities as contained in the Somersworth Water Ordinance.
- Residential properties with a pool, hot tub, Jacuzzi, or irrigation line are required to have a testable backflow device installed on the water service line.
- An approved backflow prevention device must be installed according to the degree of hazard, if a backflow were to occur.
- In cases of a high hazard threat, a Reduced Pressure Zone (RPZ) Device, or similar, is required.
- In cases of a low hazard threat, a Double Check (DC), Pressure Vacuum Breaker (PVB), or similar, is required.
