## Sample Sketch Plan

Total piping length = 84 feet

Length from a to b, demand = 38,000 + 35,000 + 30,000  
= 103,000 BTU / hr; use ¾" pipe


Length from b to c, demand = 38,000 + 35,000  
= 73,000 BTU / hr; use ½" pipe or ¾" tubing

Length from c to d, demand = 35,000 BTU / hr; use ½" pipe or 5/8" tubing

Length from c to e, demand = 38,000 BTU / hr; use ½" pipe or 5/8" tubing

Length from b to f, demand = 30,000 BTU / hr; use ½" pipe or ½" tubing

#### Notes:

It is the responsibility of all contractors, electricians and plumbers to obtain the necessary permits from the Code Enforcement office at City Hall before any work has begun. Work must begin within six (6) months of the issuance of any permit. Permits are not transferable. If this is an "After the Fact" permit, it may be subject to a fee two times the normal permit fee, not to exceed \$500.00.

It is the responsibility of the contractor to obtain all inspections required. This signed application constitutes consent on the applicant's part to allow for inspections at the property by the Code Enforcement, Assessing Office and any other required City Staff. If an inspection fails twice for the same reason, a re-inspection fee of \$25 will be assessed for every subsequent inspection. This fee shall be paid prior to each and every additional inspection.

#### **INSPECTIONS REQUIRED:** (48 hours notice required)

1. When rough-in is complete and visible (Rough).
2. When job is complete, but before occupancy (Final).

No permit will be issued until all of the above information is furnished, and all the above conditions met. If you have any questions, feel free to contact the Code Enforcement office at 692-9522 or 692-9520.

*Statement of compliance:* I have read and understand the statement and hereby agree to all of the terms stated therein. I agree to abide by any and all codes relating to my field of work, including all national, state, and local codes. I also realize that any false statement made in the application for permit may be grounds for revocation of said permit and/or a **misdemeanor** offense.

Code Enforcement Approval would certify that the applicant could proceed with certain building improvements in accordance with the specifications submitted. Any deviation from the specifications submitted will require an amendment to this permit or additional permits.
