MEMBERS PRESENT; DAVID EASTMAN, JENNIE FLAYHAN, MARY GRAVES, FRANK KENNEDY, WOODY OPENO, BRIANNE ST.PIERRE, AND TOM WILLIS CAME IN JUST IN TIME BEFORE MEETING WAS ADJOURNED., TO INFORM US THAT OUR REQUEST FOR FUNDING THE GRUB CONTROL TREATMENT WAS DENIED FOR NOW AND MAYBE FOR EVER !!! VERY DISCOURAGING NEWS!

MEETING WAS CALLED TO ORDER BY CHAIRMAN EASTMAN AT 4:00 PM. BRIE DISCUSSED THE GRUB CONTROL TREATMENT AND THE REPLY BY CITY MANAGER THAT NO TREATMENT WOULD BE DONE THIS YEAR AND POSSIBLY NEVER, ACCORDING TO PUBLIC WORKS DIRECTOR, TOM WILLIS.. MONEY CANNOT BE SPENT ON PRIVATE PROPERTY, SPECIFICALLY STONES AND MARKERS, BUT BURIAL GROUNDS MAINTENANCE IS FUNDED BY PERPETUAL CARE WHICH IS INCLUDED IN BURIAL COSTS. WE, AS APPOINTED TRUSTEES OF THE CEMETERY, ARE RESPONSIBLE FOR THE CARE AND MAINTENANCE OF THE CEMETERY,,ACCORDING TO CITY ORDINANCE SECTION 17.9 AND 17.10.

IT WAS SUGGESTED , BY THE CHAIRMAN, THAT ,IF POSSIBLE, WE COULD ATTEND A FUTURE MEETING OF THE COUNCIL OR PUBLIC WORKS AND ENVIRONMENTAL COMMITTEE, OR ATTEND THE PUBLIC HEARING ON THE BUDGET ON APRIL 23.. BRIE WILL KEEP US INFORMED ON DATES TO MEET.

WOODY GAVE US A BRIEF UPDATE ON THE MOSES TOMB WORK FROM JOHN WASTROM, HE IS NEARING THE COMPLETION OF THE COLUMNS AND COLUMN TOPS AND RESETTING THE MARBLE .HE IS TRYING TO GET IT DONE BY MAY 30TH, ONCE THAT IS DONE, HE WILL NEED TO RENT A MACHINE TO COMPLETE THE REST OF THE STONWORK, SO ALL MIGHT BE DONE BY THE END OF THE SEASON
