3:30 PM MEETING WAS CALLED TO ORDER BY ME, JENNIE. AS CLERK.  
THIS MEETING WAS SUGGESTED BY TOM TO GET OUR VIEW AND INPUT ON THE BURIAL OF ANDREW POLYCHRONIS THAT WAS MISTAKENLY BURIED IN THE WRONG LOT, BELONGING AND OWNED BY MRS ESTHER DOBBINS OF HAMPTON, N.H..

I TOOK THE LIBERTY TO CALL MRS. DOBBINS, TO GET MORE INFORMATION AND HER REQUEST TO CORRECT THE SITUATION, SHE IS A LIVING RELATIVE OF ANDREW AND THEREFORE HAS THE AUTHORITY TO HAVE THE BODY OF THE DECEASED REMOVED AND REINTERRED IN THE PROPER LOT AT THE EXPENSE OF THE CITY, ACCORDING TO N.H. THAT WAS A REASSURING REPLY AND WE ARE VERY GRATEFUL FOR ALL AND ANY HELP WE CAN GET TO PRESERVE OUR CEMETERY .

ONE MORE REQUEST WAS THE TWO NEW ROADS ARE COMING TOGETHER AND NEED TO BE MARKED MAYBE WITH LARGE STONES TO KEEP THEM SEPARATED, JENN WILL BRING A MAP TO SHOW WHICH ROADS THAT ARE IN QUESTION..
