4:00 PM MEETING WAS CALLED TO ORDER BY THE CHAIRMAN, DAVID
EASTMAN, FOLLOWING A REVIEW OF THE ONLY TWO BIDS THAT BRIE HAD
RECEIVED FROM CONTRACTORS, THAT BEING WAYNE McKAY AND RANDALL
CONSTRUCTION ... FEB. 14, MINUTES WERE READ AND ACCEPTED. .

CONSIDERING THE SMALL DIFFERENCE IN LINE ITEMS PRICING, THE FINAL
TOTAL WAS \$100.00 LESS WITH McKAY.. AFTER A BRIEF DISCUSSION ON THE

TOM WILL BE OUR NEGOTIATOR AND GIVE NOTICE TO THE CITY MANAGER
ALONG WITH A COPY OF MINUTES OF THIS MEETING.


AT OUR NEXT MEETING, IN APRIL, TOM WILL SHARE THE BUDGET PROPOSAL
