PRESENT; DAVID E., JENNIE F., MARY G., WOODY O., FRANK K., WITH
TOM WILLIS,, AND JENNIFER NALLEY ATTENDING.

MEETING CAME TO ORDER AT APPROXIMATELY 4:10 PM BY CHAIRMAN
DAVID. WITH AN OPENING STATEMENT CONCERNING THE INCIDENT WITH
CHILDREN PLAYING IN THE CEMETERY RESULTING IN ONE CHILD GETTING
HURT FROM A FALLEN GRAVESTONE. TOM REPLIED THAT NO OFFICIAL
CLAIM HAS BEEN MADE SO FAR TO DATE. JENNIFER RECEIVED SEVERAL

THAT McKAY WILL BE DOING THE EXCAVATING FOR THE GRAVES.


MARY NOTED THAT BOTH NEW ROADS ARE ERODED. TOM WILL PUT A
