## **Agenda and Meeting**

**I. Call to Order:** At 4:00 pm by the Chair.

**II. Approval of Minutes:** Motion to approve the 20 May 2018 minutes as submitted was made by Ms. Ward and seconded by Mr. Murray. Motion was adopted unanimously.

**III. Old Business:**

### **A. *Toppers Rock 2018* band concert**

The Chair reported that the August concert was now listed on Facebook; tickets at \$20 each are available online at Eventbrite; they may also be purchased at Brenda's office (Secretary to the City Manager), and at the Great Falls Chamber of Commerce (formerly the Greater Somersworth Chamber of Commerce).

Mr. Lavalle filled the Commission in on the latest details. Mr. Lavalle is still waiting for a response from Port-A-Potties (estimated cost \$200 per toilet x 4 = \$800). Mr. Lavalle reported that our bands had been contacted and agreed to appear: Acoustic Radio, Ovation, Bad Breath, and Terri Collins. Mr. Lavalle furthermore reported that the event must pay for sound; the Chair asked for a price to budget the event correctly. Mr. Kennedy recommended inserting the 125<sup>th</sup> Anniversary logo into the concert sign. Mr. Lavalle stated that he was trying to get more classes from SHS involved as the money raised from food sales would benefit them (estimated to be between \$1,000-\$1,500). Old Railroad Pizza will have a 7' flatbed offering a more extensive menu. The SAA will set up the big tent.

There was some discussion about the beer tent; Mr. Lavalle had not yet heard from the beer company he had first approached. The Chair stated that a cut off date to plan the beer tent needs to be set. A meeting of the concert subcommittee was set for Saturday, 21 July 2018, to finalize details for serving beer.

There was some discussion about what permits would be required. The Chair said that she would ask the City Manager which permits from the city would be necessary. The Chair directed Mr. Lavalle to seek a state liquor permit. There was some discussion about police presence and payment, monitors particularly for the beer/alcohol tent, and disposal of garbage.

The Chair explained that she needed to finalize the budget for this event so that the Commission would know how much it had for the remainder of the year. Expected costs for this event include: fees associated with the printed banner; license fees; Port-A-Potties; garbage pick-up and disposal.

### **B. Cancelled Fireworks Display**

The Chair reported that there would be no fireworks display as no specific date could be identified or worked out.

The Chair asked Commissioners to think of another event which would not cost too much money to substitute for the cancelled fireworks display. The Chair mentioned that the Ten Commandments monument at Citizens Place needs an historic plaque.

### **C. Two recent events with 125<sup>th</sup> Commission participation**

The Chair reported that there was a 125<sup>th</sup> Commission presence at two recent events in Somersworth. On 10 June 2018, the Commission sent participants (thanks to Mr. Brooks and Mr. Murray) to the Cemetery Trustees' tour of Forest Glad Cemetery with Peter Michaud. On 17 June 2018, the Commission sent participants to man a booth at the 2<sup>nd</sup> Annual Food Truck Festival (thanks to Councilor Michaud and Mr. Murray).

The Chair announced that the Cemetery Trustees have also invited the Somersworth 125<sup>th</sup> Anniversary Commission to attend a string quartet performance on Sunday, 19 August 2018, beginning at 2:00pm, and to an historical re-enactment with local actors taking the part of individuals buried at Forest Glade or their family members on 29 September 2018.
