- **c.** M. Bobinsky confirmed that State Highway personnel who installed the new Historic Sign at Forest Glade generally installs in the same manner with the front of the sign facing the street.
- **d.** Confirmed we have a new volunteer who will be adopting the raised garden bed at the Cremation Garden.
- **e.** M. Bobinsky reported that trustee A.Visser located a consultant in the Boston area who may be able to help obtain a price quote for preparing an appraisal to assess the value of the 12 stained glass window panes in the Furber Chapel.

New Business

a. N.Larson mentioned the possibility of cleaning up the walls in the Furber Chapel. Paint is peeling and will need to be redone. This could be associated with a future historic preservation grant that staff would need to apply for; possibly a future LCHIP or Moose Plate Grant. The City's FY25 CIP does show further Chapel Restoration work in FY25 which is under review now by the City's

- Planning Board and the City Council. The funding is subject to grant awards and approval of local match funds.
- **b.** There is a tree overhanging the North side of the Chapel that will need to be removed. Highway Division has been made aware of this and on the list to be trimmed back as soon as time allows.
