Old Business (under Section 13 of Agenda)

Ordinances:

- A. Ordinance No. 23-14 Transfer Between Departments.** This Ordinance was reviewed by the Finance Committee at their June 5th meeting. The Committee voted to endorse the recommended transfers. Attached is a memorandum and FY2014 budget printout update.

New Business (under Section 14 of Agenda)

Resolutions:

- A. Resolution No. 46-14 To Continue Water Service to Three Dover Properties.** Although these Dover properties are recognized as customers in the newly adopted City Water Ordinance, this housekeeping vote is recommended by our City Attorney. The Dover City Council recently voted to recommend this continued service. The Public Works & Environment Committee did decide to recommend passage in order to clean-up this issue at the Public Utilities Commission level.
