

## **Special Municipal Election Tuesday, September 11**

The City of Somersworth will be holding a Special Municipal Election on Tuesday, September 11, 2018, to fill the **Ward 5 City Council** seat for the remainder of the term to expire in January 2020.

### **FILING PERIOD**

In Accordance with RSA 669:16, the filing period for Declaration of Candidacy for the Ward 5 City Council Seat will open on July 25, 2018 and close on August 3, 2018.

Persons wishing to be a candidate in the September 11<sup>th</sup> Special Municipal Election must file a Declaration of Candidacy in the Office of the City Clerk during the filing period. A \$5.00 filing fee is due at the time of filing. In lieu of paying the fee, a candidate may elect to file 25 notarized petitions.

Candidates must be qualified voters residing in Ward 5 in the City of Somersworth. Names of all candidates will be placed on the ballot in order pursuant to  
RSA 656:5-a.

### **Somersworth gets \$200k EPA Grant**

EPA New England Administrator Alexandra Dunn was in Somersworth to publicly announce the awarding of \$700,000 worth of Brownfield's Grant to New Hampshire. The \$200,000 Somersworth received will allow the City to remove the remaining contaminated soil from the grounds at 1 Winter Street, and then return the land to the tax rolls. Mayor Dana Hilliard said at the presentation that the award demonstrates "the good that government can do when it works collaboratively".

Before Breton's Cleaners, the Winter Street property was owned by Prime Tanning from 1974 to 1982, which also owned a leather tanning mill across the river in Berwick, Maine. From 1850's to 1974, the 6-acre parcel served as a railroad freight depot owned by the Boston and Maine Railroad.

City Manager Bob Belmore stated "last year the City was awarded \$178,000 Grant from the NH Department of Environmental Services. The City used this to remediate and demolish the former building on the site. This Brownfield's Grant will allow us to bring life back to a prime piece of property located at a gateway to our downtown adjacent to the Salmon Falls River".

### **From the Desk of the Economic Development Manager "Branding your Business"**

Business signs and advertising signs are one of the most efficient and effective means of communication. Signs help people find you; they reach people who are passing by your establishment; they present an image of your business. In short, signs tell people who you are and what you are selling.

The power of something as simple as a sign also creates a tremendous opportunity. The sign is a direct way of conveying a message about your business; and it allows you to tell your business's story. The quality of your sign, your font, and color choices all make an impression. The simplicity of your company sign is the first step in creating a public impression. Your company name, your logo, and your image, as well as your stylistic approach to the products and services you provide are all represented in your sign. Signs can build an image for your business and help you identify with the market segment you are trying to reach.

In Somersworth different signs are allowed in different zoning districts and the size of the sign allowed is contingent on the size and type of your building. The two major commercial zones are: High Street /Rte 108 and Downtown/Main Street.

- **Downtown and Main Street:** Signs attached to buildings are limited in area so that the sign shall not exceed 10% of the total area of the front wall (face) of the building. In the case of a multi-story building, the sign shall not be more than 10% of the face of the first story. One freestanding sign per lot is permitted. The size of the freestanding sign shall not exceed 20 square feet in surface area on each of two sides for a total of 40 feet. Please refer to ordinance section 19.20.D.2 for a complete list of rules pertaining to the zoning districts Downtown and Millyard zones.
- **High Street and Route 108:** For a single business the permitted sign area per lot will not exceed 50 square feet, plus 1 additional square foot of

sign shall be allowed for each additional linear foot of principle building frontage in excess of 50 linear feet, to a maximum of 100 square feet. For a multi business, one free standing sign shall be allowed for a multi-business building or shopping center. The maximum sign area allowed shall be 48 feet plus an additional 4 square feet for each business to a maximum of 72 square feet. Please refer to ordinance section 19.20.D.4 for complete list of rules pertaining to the zoning districts along High Street and Route 108 including the Residential & Commercial Districts (R/C) the Residential/Office (R/O) District and the Commercial/Industrial District.

There are many more Zoning Districts in the City. Each District may have its own set of rules and regulations, so please make sure to call Robin Comstock at 603-692-9516 or [rcomstock@somersworth.com](mailto:rcomstock@somersworth.com) when you first start planning your sign.

For the purpose of this article, know that regardless of whether a business is located in a residence or in a commercial structure, a permit is required for signs. The process to obtain a permit is very simple. (1) Contact the Department of Development Services (603-692-9516) to find out the zoning district of the property where the sign will be placed and to obtain a sign application. Applications are also available online <http://www.somersworth.com/wp-content/uploads/2012/10/Sign-Permit-Application.pdf> (2) Complete the application and provide dimensions and a drawing of the proposed sign, as well a photograph (or drawing) of the structure and its distance from the street, with an image of what the proposed sign will look like on its structure (3) the Somersworth Sign Committee will review the application (4) You will be contacted with the conclusions of the committee within 14 days. <http://www.somersworth.com/wp-content/uploads/Chapter-19-Zoning-2.pdf> for more information on the sign ordinance. ### **Storms**

Many thunderstorms and high winds occur during the summer months. Occasionally there are high winds that accompany the storms. Power loss can occur and electrical wires can be knocked to the ground by fallen trees or branches. It is best to have a plan beforehand to deal with these occurrences:

- Have flashlights easily available in the home
- Have a battery operated radio to get updates about the storm and conditions on the roads
- Enroll your cellphone with NH Reverse 9-1-1 or Nixle for emergency messages

### **Gas Grills**

Summer means outdoor grilling of food, among other things. Grills fueled by LP gas are abundant. Fires sometimes occur when the open flame impinges on rubber hoses delivering the fuel to the grill. Wind driven flames or grills needing cleaning or maintenance often are the cause of fires as well.

- Keep grills away from buildings and combustibles (10 to 15 feet)
- Clean your grill frequently

- Maintain your grill in good condition

### **Gasoline Usage**

Gasoline usage during warm months can be dangerous due to fume discharge and pouring gasoline into lawn mowers and other machinery with hot motors. Remember that gasoline is highly flammable and fumes can travel distances and ignite. Small motors usually dissipate heat quite well but injuries occur every year due to gasoline accidents.

### **Portable Fire Extinguishers**

Everyone should carry a portable fire extinguisher in their car and have at least one located in the home - preferably close to the kitchen.

An A-B-C type should be used as it will extinguish all types of fires except flammable metals. At least a 10 pound unit should be purchased. Only those with metal triggers/nozzle assemblies typically can be recharged. Most dry chemical extinguishers today are disposable (plastic parts) and usually can hold a charge for 10-12 years. As they are mostly disposable there is no way to recharge them if used or the charging agent leaks out.

### **Road Improvement Updates:**

Road paving bids were released recently to area and interested contractors. Bids were due on July 19<sup>th</sup> and staff is presenting reviewing the bid results with the City Council Finance Committee and Public Works and Environment Committee. Streets planned for overlay include:

Washington Street (High Street to Main Street)  
Tates Brook Road (Maple Street to W. High Street)  
Salmon Falls Road (State Line to City Line)  
Otis Road (W. High Street to Rocky Hill Road)  
Horne Street (High Street to Myrtle Street)  
High Street (Blackwater Road to South Street)  
Constitutional Way (Washington Street to High Street)

Later this fall, NH DOT will be repaving their portion of West High Street from Rte. 108 to Maple Street and the City will be repaving West High Street from Maple Street to Cemetery Road.

### **Complete Streets Design Work Underway**

The engineering firm of Wright Pierce is making progress with early design work

for the re-engineering of Main Street, Constitutional Way and Cemetery Road. The design work involves developing specifications for future rebuilding of all three streets and incorporate new water and sewer lines, storm drainage, sidewalks and street landscaping features. Look for announcements in early fall on public meetings presenting preliminary engineering and design plans.



### **What Somersworth is Reading in August**

#### **"The Last Runaway" by Tracy Chevalier**

Honor Bright, a modest English Quaker, moves to Ohio in 1850--only to find herself alienated and alone in a strange land. Sick from the moment she leaves England, and fleeing personal disappointment, she is forced by family tragedy to rely on strangers in a harsh, unfamiliar landscape. Nineteenth-century America is practical, precarious, and unsentimental, and scarred by the continuing injustice of slavery. In her new home Honor discovers that principles count for little, even within a religious community meant

to be committed to human equality.

However, Honor is drawn into the clandestine activities of the Underground Railroad, a network helping runaway slaves escape to freedom, where she befriends two surprising women who embody the remarkable power of defiance. Eventually she must decide if she too can act on what she believes in, whatever the personal costs.

Summer camp is in full swing, and the Recreation Office day-campers showed off their recycling savvy in a





## CEMETERY CORNER

### **Forest Glade Cemetery Named to National Register of Historic Places**

Forest Glade Cemetery in Somersworth has been honored by the United States Secretary of the Interior with placement on the National Register of Historic Places. Forest Glade was developed as the City's primary public cemetery in 1851, after Somersworth and Rollinsford became separate municipalities. Roads, paths and landscape features wind throughout its 22 acres, making it a notable example of the mid-19th century Rural Cemetery Movement begun at Mount

Forest Glade includes a variety of structures and artifacts that chronicle more than 100 years. Funerary art. Classical Revival, Eastlake, Gothic Revival, Greek Revival, Italianate, Victorian Gothic and Rustic styles are all represented among the headstones, obelisks, monuments, tombs, mausoleums and well houses. Of special note is the Furber Memorial Chapel, designed by architect Henry Vaughn to seat up to 70 people and dedicated in 1898.

City staff have been involved in several specific historic preservation projects over the past few weeks, including completing the repainting of the Italianate Well House in historic period colors, soliciting proposals to restore the Cemetery main entrance gates and granite monuments off of Maple Street in working with a Preservation Consultant to complete a building assessment of the Furber Memorial Chapel. Both the building assessment of the Chapel and the future restoration of the main entrance gates is being funded with State Historic Preservation grant funds. In addition, the City has hired the firm "Beyond the Gravestone" to restore 5 historic grave markers in Forest Glade Cemetery; work on the grave marker restoration is set to occur in mid-August.
