ROUTE: The parade route will start in Berwick from Wilson St. then straight across to Allen St. (RT. 236), turn right onto Sawmill Hill Rd. down to the bridge crossing into Somersworth on Market St, onto High St, turn left onto Constitutional Way, left onto Washington St, and disbanding to the right on Green St, Elm St. and Main St.

The Winter Gala will take place downtown by the Somersworth Library and will begin at 8:30pm. The Winter Gala will include: an ice sculpting demonstration, dancing performances, and singing by local school children. Wrapping up the evening will include spectacular fireworks, sponsored by the City of Somersworth 125th Commission and Hilltop Fireworks, going off at about 5:00pm. The annual lighting of the City of Somersworth Christmas Tree with caroling for all to join in will take place at about 5:30pm! The tree is located near the old police station.

Seek alternate routes through the downtown area between 2:30 pm. and 4:00pm due to the Christmas Parade.

The Mayor's Corner

Honoring my Father through a Plastic Santa

The importance of traditions are lost to us when we are young. They were often dreaded, and looked upon as a burden that prevented us from partaking in the activities we really wanted to be engaging in like riding our bikes, spending time with friends, and during the winter, building snow forts or having neighborhood snowball fights. I have very little to complain in terms of the inconveniences of family traditions as had very few in my youth. Like most families, we would gather at the table during Thanksgiving, and count our blessings through our indulgence of food. During the holiday season, we would celebrate Christmas by putting up an artificial tree, until my teenage years when my parents switched back to a real one. Apparently, my younger sister and I were to blame for the original switch to an artificial tree, due to our preemie and adolescent childhood asthma. As we aged, the asthma cleared and the return of a live tree made its way back to the Hilliard's house on Indigo Hill Road.

Christmas morning was spent opening presents which then cleared the afternoon for me to touch base with my friends and talk about "what we got". This of course pre-dated cell phones, and calling on a land line was really not our style, so instead all of us would grab one toy and converge on the predetermined house to gather and share. It seemed for hours that we would run through the list and compare "how we made out," while starting to make plans for the remainder of the school break. There are many similarities between the characters in the movie, "A Christmas Story" and the guys I hung out with during my youth. It was a different time period, but the same childhood innocence and mischief.

During my late teens, new holiday traditions would emerge. We would begin by gathering at my sister and brother in-laws house for Christmas Eve, to celebrate the holiday together, as new families began to form and expand. Again, we would overindulge in eating, and a Christmas card game with gifts would be introduced. The main goal of the game was to insure that my father received no gifts, and this tradition is still honored to this day. I'm not sure of the exact date (although a member of the Summersworth Historical Society might have it) but

around the same year we began this Christmas Eve gathering at my sisters, the Christmas Blow Mold Santa appeared in the garage window at Indigo Hill Rd. Somewhere during my father's travels he had acquired it, although to this day none of us are really sure how it arrived. This plastic light up Santa, as I like to call it, became my father's prized possession. He would talk about it throughout the year, and would view its re-emergence and lighting of equal importance to that of the lighting of the National Christmas tree, or of the tree at Rockefeller plaza. I am convinced, if given the choice that he could only maintain one earthly possession in life, the plastic light up Santa would win every time.

As the holiday season arrived, from the top corner in the garage, the plastic light up Santa would make its way to the window. For decades, my father would brag to me how everyone in Somersworth loved it, and how "they expect" for him to put it in the window each year and light it up. His obsession, and ego related to the plastic light up Santa, drove me insane. I could not comprehend why he loved the darn thing so much, or how he really thought that everyone in Somersworth marked their holiday calendar around the re-appearance of "Gordie's light up Santa". For some reason, just looking at the Santa often angered me. I remember walking in on the biggest argument I ever witnessed between my parents. They had contracted to have the garage re-sided, and have all new windows put in. My mother had picked a design she had fallen in love with, to include the round window which is at the top of the garage. My father, however, was not convinced that the Santa could be seen with the new design and window, so therefore canceled that design and instead ordered a larger traditional style window so the Santa could be seen by all. My mother discovered what had occurred and the Santa war began. Luckily, my role as a member of the United Nations prevailed that day and I was able to convince my father that the plastic Santa could be seen and enjoyed by the round window design my mother had chosen.

As we move through life, we become more awakened. We gain insight and understanding of the things that are important: life, family, friends and traditions. We experience the aging of our parents, their "slowing down", their passing, and we experience the reversal of roles as we become their caretakers. My father's energy is not the same as it was when the plastic Santa first arrived. Battles with cancer and Alzheimer's have begun his final process in the circle of life. Along with his battles, an outdated electrical system in the garage has led to a few years of darkness with the plastic Santa. It is with that darkness, that I realized its importance, and what my father saw in it. I have lost track of the amount of people who have stopped me, and asked why my father no longer lights up the Santa, and when will it be returning. Each time I had to explain the reasoning behind its absence, it became more important to me. The object, which I use to loathe, became the object that I most desired to possess.

We are the guardians of memories; we are the guardians of traditions. Each generation will be given the choice to keep memories alive, or to let them fade, to

continue traditions or to have them halt. This is an incredible responsibility inherited by each of us, and one of the greatest we will have during our life time: the choice to continue the family history and traditions, or to have them end and create new ones.

I have willingly, with honor and pride, become the guardian of the light up plastic Santa. To my surprise, when the torch was passed, I discovered there were actually two Santas. They now illuminate that dark dead end street that I live upon. Each night I throw the switch to power them up, I feel as if I am restoring my father's energy, and spreading the love and happiness he had for every holiday season. It brings me joy to carry on the tradition of "Gordie's plastic Santa," and while its location has temporarily moved, I have also inherited my father's insanity associated with it. I have had conversations with my mother on why getting the electrical system in the garage updated is important to ensure that Santa can be re-lit in the window at Indigo Hill Road, and that the tradition of "Gordie's plastic Santa" can live on.

As the new guardian of "Gordie's plastic Santa", the tradition will continue with me. I look forward to Christmas in the future when both Santas will shine their light, one from the window of the garage at Indigo Hill Road, and one from my own porch. It is my duty now to continue the tradition, to continue to shine its Christmas light, and to remind all of the nature of the holiday: honoring each other, carrying on traditions, and celebrating the universal bond we all share. Its light will continue to shine long after my father's is extinguished, and with each lighting, I know it will remind me of him. Like my father, I now look forward to its relighting each year, and look forward to the day when I will pass on the tradition of "Gordie's plastic Santa" to another to honor and continue.

We are a community! We are achieving progress and greatness!

To renew your permit the fee is \$10.00 if paid before the end of January, 2019 or \$20.00 after. If the alarm is for a residence and you are 65 or older, your permit is free. Snow Emergencies Winter Parking Ban

Snow Emergencies can be called at any time, day or night. During Snow Emergencies, a Parking Ban is in effect. Always be aware of overnight weather forecasts and have alternative parking plans when snow is predicted. Your vehicle can be towed during a Snow Emergency and

you will have to pay the tow charge to get it back. The purpose of the parking ban is to enable Public Works to safely maintain the roads. This means sometimes there will be a Snow Emergency declared even when it is no longer snowing. Snow emergencies are announced on the following stations: WTSN, WOKQ, WERZ, WSHK, WHEB, WMUR Channel 9 and Local Cable Station Channel 22. You may also call the **Winter Ban Hot Line at 692-9131** or go to www.Somersworth.com. To receive news of parking bans via email, go to www.Somersworth.com and click "Subscribe-City Email."

Winter Safety Tips

- The holiday season is a festive time for most of us, but remember that this time of year also yields many fires due to unattended candles, overloaded electrical circuits and natural Christmas trees that dry out and become fire hazards.
- The winter heating season is upon us. Furnaces and boilers will be working hard to keep buildings warm. Inefficient heating appliances may cause carbon monoxide so be certain to keep furnaces serviced annually. Also be sure to have a carbon monoxide detector on every level of your home.
- The winter season also has its share of power outages due to stormy conditions. Those who have generators are cautioned to locate them away from homes and air intakes. Also, be sure to shut off normal electrical power at the main fuse panel so generator power does not backtrack into the street and cause possible electrocution hazards.

Waste and Brush Collection

Christmas Holiday Schedule

Reminder that Residential curbside collection of Trash and Recycling will run on **its normal schedule on Monday, December 24. However, Tuesday December 25 a one-day delay will occur.**

Tuesday's collection will be on Wednesday and Wednesday's collection will be on Thursday.

Trash and Recycling Reminders

Reminder that use of trash barrels for storing the blue trash bags or recyclables is acceptable only if there is no cover/lid on top. Also, the contents must be clearly and easily noticed that it is a blue bag or acceptable recyclables, otherwise the contents will not be collected. These requirements are necessary as the solid waste operator does not have time to remove the lid, or conduct inspections of the contents. In addition, this is a reminder to not use plastic bags to hold the recyclable material in the container and to ensure that the recyclables are free of food waste.

Metal/Electronics Collections

Reminder the next Metal/Electronics curbside collection by Public Works crews will occur on Tuesday December 11, 2018. Residents should call by Monday December 10, 2018 to be placed on the pick-up list. Use of bulky waste stickers is required and can be purchased at City Hall, City Clerk/Treasurer office and at the Somersworth Public Library (cash or check) and at the DPW building at 18 Lilac Lane (check only).

Residential Brush pick up and Bagged leaf collection services suspended until Spring 2019.

Residential Brush pick up and Bagged Leaf collection suspended until spring 2019. Unfortunately, the early winter snow conditions have impacted planned collection operations. To the extent conditions allow, Highway crews will collect what material is already set out, but limited to the extent material is accessible and safe to collect. Look for future announcements during later winter 2019, on the spring collection schedule.

Update on City Road Repair Work

The City's paving contractor Brox Industries made strong progress on addressing several roads scheduled for repair and resurfacing. A rainy fall combined with early-onset winter conditions caused paving and road repair work to be suspended. Several road improvements were completed before operations ended.

Additional Road improvement work will return as soon as conditions allow in Spring 2019

Residents reminded to "NOT" have Direct Sump Pump discharges into City sanitary sewer manholes or stormwater catch basins.

Public Works Highway crews have noticed some properties have roof downspouts, foundation drains, and area drains that discharge ground water directly into nearby catch basins or sanitary sewer manholes. This is in violation of the City's Sewer Use Ordinance (8A.21 section 10) and can contribute to overcharging the basin or sewer manhole. This creates ice and freeze conditions that are hazardous to pedestrians and motorists, and may carry pollutants into the City's storm sewer system. This has been particularly noticeable during cold weather conditions where the discharge flow will freeze on streets and sidewalks.

Please contact the Department of Public Works Highway Division at 692-4266 if you have questions or need additional information on how to redirect this runoff from your property.

Winter Season has started early!

Residents are reminded to use caution when driving in inclement weather, snow and ice conditions warrant traveling at lower speeds, do not tailgate and give extra space to City Highway Plow operators who are salting/sanding or plowing streets. Residential sand is available at the DPW Facility located at 18 Lilac Lane and next to the main parking area. Residents are limited to two (2) buckets of sand per visit.

Parking Bans

The City will typically implement a City-wide parking ban during most plowing and downtown snow removal operations to ensure safety and efficient clearing of snow from streets and designated sidewalks. Parking ban announcements are made via social media updates on a routine basis (email blasts, web site notices and Nixle alerts) and when possible in traditional print media. Residents and businesses are encouraged to sign up for the City Managers Newsletter which will automatically result in receiving other emergency alerts and updates on such key topics as parking bans to keep you informed and avoid a ticket or a tow if in violation.

Together they removed the stump with chains and the horsepower of his truck, and planted a healthy Honeycrisp apple tree in its place, plus one more for good measure. It may take a couple years, but those apples will taste amazing accompanied with the maple syrup that Mr. Dunbar produces at SMS with his students in spring.

The November 7 Farm to School Community Dinner was a great success. Over

150 people turned out for a delicious meal of chicken pot pie, steamed broccoli, and fresh biscuits with maple butter; the majority of the vegetables came from Somersworth's school gardens and donations from NH Gleans.

Local apples were featured in the apple crisp dessert, and a creamy sweet potato pudding with local cream was another treat. In addition to being a mostly locally sourced meal, all plates, cups and flatware were compostable, with Toby from Mr. Fox donating the composting totes that are now on their way to becoming soil for our gardens. Funds from our USDA Farm to School grant paid for most of the food, and donations of labor and product from local businesses such as Ovington's, Smoke and Cream, 45 Market St Cafe, Cafe Services and Mr. Fox made the night a true community event. Big thanks to all the families who turned out to volunteer; it takes a village, and wow what a village we have here.
