Subject: Proposal : Sunningdale Dr, Cottontail Project

As I listened to the Dec 9th Conservation Commission meeting, I was pleasantly surprised to hear that the NRCS, NH Fish and Game and other representatives were willing to hear and consider our concerns as home owners. As important as this project is to the NRCS and other agencies, it is also of utmost importance to the home owners, many of whom bought into this development due to the views and the wildlife. I would like to make a proposal that I believe may be acceptable to all concerned.

I have taken several walks in the hillside and have seen where the trees and bushes have been flagged. If I understand correctly, the area where the trees are tagged in blue, will be trimmed but some hardwoods will be left. The yellow ribbons indicate the existing NEC habitat. The areas tagged in blue seem to be over the crest of the hill, as seen from Sunningdale Dr . There were no signs of blue tags on any trees in the fairways.

I have taken GPS coordinates in relation to the crest of the hills and my proposal is this, please see attached map (provided by the USDA). A black line drawn between the two GPS coordinates (43.23340, -70.87093 and 43.23136, -70.86998) appears to bisect the area of the first blue tagged trees. What I propose is to leave the trees, conifers and hardwoods, to the east of this line, and have NRCS cut as needed to the area to the west and south of the existing area.

The green-hatched existing rabbit habitat encompasses 11 acres with an additional 8 acres that are under review (yellow-hatched). The area to the west of the proposed line, and south to the conservation boundary, could result in as much as 10 - 15 additional acres. Someone at the last meeting stated that the required acreage for a habitat is around 20 acres. With the existing habitat and cutting to the west of this line, I feel that you should easily be able to meet that requirement.

I hope you will consider this request. I understand that this just a proposal and as such is subject to adjustment and revision. I believe that the proposal would meet the needs of both the NRCS and the home owners. I look forward to hearing from you. Please feel free to contact me if there are any questions or clarifications needed.
