3. New Business

A. Sustainability Committee Report

No report at this time

B. Getting map coordinates for easement monitoring

Michelle stated conversation with SRPC ongoing; they need a prioritized list of our easements to proceed. A. Ficco will provide with S. Eckstein's assistance.

Sunningdale and Malley Farm are the top priorities; M. Mears will pursue these two sites.

C. Unauthorized tree cutting, trail signs and bridge construction at The Oaks 2 easement

S. Orzechowki will contact the individual who was discussing this work; M. Mears will ensure that code enforcement contacts as well. This appears to be an existing trail system that has been recut and modified. This work is on conservation land.

D. City invasives controls

S. Orzechowski will reach out to Rebecca DiGirolomo to develop a plan for the City Manager. Intent is to assist the city with budgeting for control efforts.

E. Entomologist walks

A. Ficco has met with the US Forest Service Entomologist; this individual is acting as a private citizen and reached out on learning about the Mayor's Monarch Butterfly pledge. They will look into establishing a walk. This is related to the Mayor's pledge; a network of approximately 300 mayors and tribal leaders who are seeking to raise awareness and support habitat for monarch butterflies along their migratory route in response to the species' declining numbers. Goal is to encourage additional habitat space, focusing on food sources including milkweed and nectar-bearing plants. Primary sites under consideration are Ash St. Playground, Malley Farm, and city schools. Will also look to increase involvement throughout the city.

F. Backyard habitat promotion

S. Orzechowski has spoken to mayor regarding this effort. Emplacement of habitat including native plants throughout city should be encouraged; in addition to wildlife and plant diversity benefits, native plants require far less care than exotics.

G. DES stewardship plan for 53 Coles Pond Road easement

M. Mears has worked with the DES to establish the plan; it's compliant and approved. Monitoring will be required. Copies of the plan will be distributed to the committee.

H. Detailed 53 Coles Pond Road baseline

Baseline has been completed; will be distributed to the committee. Walk noted numerous varieties of wildlife, including bobcat. Some invasives noted; management will be required.
