## 2. Public Comment

#### 3. New Business

A. Palmer Gas and Oil is seeking a Conditional Use Permit for impact to the Woodland Buffer to allow propane tank inventory storage and stormwater treatment area associated with a site development on a property located at 73 Gator Rock Road, in the Industrial (I) District, Assessor's Map 47 Lots 1H, 1I, 1J, & 1K, CUP#04-2022

Bob Stowell of Tritech Engineering presents for the applicant. This is an expansion of an existing project. All previously approved work is complete, and the applicant is looking to expand their operations on the site to include additional tanks, truck parking and service, and some office space.

Tree cutting is minimal, and will primarily occur in currently disturbed area with scrub/pioneer species. Approximately 5000 sq feet area of older growth will be involved. All materials stored on site for distribution will be gaseous phase at STP; all oil developed as part of service activities not captured during work would enter a closed system oil trap, not permitting infiltration. The capacity of the closed system is 3000 gallons; cleanout would be moved off site. Snow storage would be placed to direct melt to the forebays; these areas would be the old cul-de-sac and uphill of the current propane tanks.

Invasives on site would be mulched and reused as part of erosion control, limiting possibility of off-site transfer. Pavement milled will travel offsite for recycling.

The landscape plan was not included in the distributed packets, and was not presented at the meeting; the commission expressed a desire that plants used be on our approved natives list.

- J. Rhodes moved to recommend the planning board grant the CUP as requested with the following stipulations:
  - That all disturbed vegetation remain on site to reduce risk of invasive species spread, and:
  - That all species included in the landscape plan be on the city's recommended natives list.

- iii. Invasives plan sub-committee report D. Smith-Kenyon met with UNH Cooperative Extension regarding this item and received webinar information. Durham's plan could be a good model for ours. Forest Management will be needed as well; D. Smith-Kenyon to continue investigations.
- Prime wetlands and vernal pool identification S. Orzechowski, J. Degler, and K. Dodds are collaborating on this item. Working on determining guidelines; Council approval will be required for final determination. Focus will be on public land, with particular attention to contiguous terrain and match to NRI. UNH is a potential resource.
- UNH Cooperative Extension collaboration for shrub ID walks First walk scheduled for 3/17; interest is very strong and more will potentially be scheduled.
