



Minutes of City Council Meeting Monday, February 7, 2022

ROLL CALL OF MEMBERS

The meeting was called to order at 7:00 p.m. by His Honor, the Mayor, Dana S. Hilliard and, upon roll call, the following Council members were present: Pepin, Vincent, Dumont, Austin, Michaud, Witham, Gerding, Cameron and Messier.

PLEDGE OF ALLEGIANCE

Councilor Witham led the Pledge of Allegiance.

PUBLIC HEARING

Ordinance No. 6-22 - Supplemental Appropriation for the City's Share of a Grant Match for the Purchase of Police Department Body-Worn Cameras

Mayor Hilliard opened up the Public Hearing for comments. No comments were heard.

COMMENTS BY VISITORS

There were no opening comments by visitors.

CONSENT CALENDAR

- A. Approve Minutes of the City Council meeting held on January 24, 2022

Councilor Austin made a motion to approve all items in the Consent Calendar. The motion was seconded by Councilor Cameron and passed 9-0.

COMMENTS BY CITY COUNCILORS

Councilor Gerding wished Mayor Hilliard a happy early birthday since the Mayor will be absent for the meeting on his birthday.

COMMUNICATIONS

- A. Report from SRPC Executive Director Jennifer Czysz

SRPC Executive Director Jennifer Czysz, joined by James Burdin, updated the City Council on planning projects they are managing for the City. Regarding transportation, they have been helping to facilitate the City's projects within the NH DOT's 10-year plan as well as the infrastructure investment and Jobs Act; which includes the feasibility of exit 10 to the Spaulding Turnpike. On the planning side of things, Ms. Czysz informed Council of their updated website to make things more user friendly. Another new item is a data snapshot, which is a 1- or 2-page annual summary page of all planning projects. A POP! Recreation viewer is also a new addition which allows users to view pictures of over 350 recreation sites in the region. Ms. Czysz stated the SRPC is currently soliciting interest from municipalities on their age friendly communities' program. She also noted a breakdown that was provided to Council outlining how the City's dues are utilized.

James Burdin, who oversees economic development projects for the SRPC, explained they receive standard EDA funding from the US Economic Development Administration and have also received some CARES Act funding. Mr. Burdin explained he is on weekly economic development calls in order to learn about the most recent assistance programs. Some of the CARES Act funding is going towards a record digitization program in order to scan and codify old site plans, records, etc. Somersworth is scheduled for February 22 through March 21 for this program. Mr. Burdin also manages the City's Brownfield's assessment program on 5 different sites and provided Council a handout on their status.

MAYOR'S REPORT

Mayors Report for City Council Meeting February 7th, 2022

As Hilltoppers throughout the Pandemic we have continue to exhibit our resiliency and our dedication to the Hilltopper spirit of neighbor helping neighbor. We navigated our way through the adversity, and through the dedicated efforts of our team approach to governing, kept our city government open and kept focused on keeping Somersworth "On the Move". Through the efforts of the Mayor and City Manager's office, we were able to provide communications to our residents on how to keep themselves safe, and the services available to themselves and their families.

The strong partnership between Stewarts Ambulance and the Strafford County Public health network led to large vaccination clinics being planned and executed. To date, rolling vaccinations are still occurring within and throughout the school system, including weekly testing which has allow in person learning to occur. While other communities debated mask mandates, our approach to educate and informing led to success of voluntary compliance. Our Council continues to model the importance of wearing mask, with the continued use of mask wearing at all Council, Board, and Commission meetings.

With the large drop in reported spread, light appears to be breaking through the clouds. While we are excited and filled with optimism with recent reports from the medical community and scientists, however, now is the time to stay the course. The word endemic continues to be widely spoken among those managing the pandemic at the top level. So too does the phrase cautiously optimistic. Both words combined means we are not out of the woods yet, however, we are moving in the right direction as we approach summer.

On the City end, we are dedicated, as we always have been, to returning to a safe state of normalcy as soon as we can. It is important that as we move towards spring and summer that the activities and festivals that our part of our Community return; so too is to hold these events in a safe fashion with minimum risk of exposer or spread. In house, our safety team will continue to stay abreast to the numbers, and when it is deemed safe, we will return to voluntary wearing of mask at Council, Board and Commission meetings.

While the word, endemic is still on the horizon, now is the time to plan on how our Community will navigate living with the virous when an endemic has been declared. As we approach the spring and summer after we have concluded our budget responsibilities, it would be pertinent for our Emergency Management Director to update this body and the Community on how Somersworth has fared throughout the pandemic along with suggested actions and plans all of us should have in mind when we reach the endemic level. The City Manager and I will meet to find a feasible date for a future agenda item.

Somersworth, we should be proud of how we have adhered to our values throughout this historic test. Together as a team, we will continue to overcome this pandemic..... How? By being Hilltopper Strong.

REPORT OF STANDING COMMITTEES

Finance Committee – Councilor Witham stated the Committee met last on February 1st and discussed and supported increasing the City's contribution to the SYC program from \$5,000 to \$50,000. The program decided to be self-sustaining, rather than seek grant funding due to the increasingly competitiveness of the grants available as well as the stipulations confining what the group can and cannot do. The Committee also discussed the road resurfacing and crack seal bids and recommended PaveX, Inc. out of Methuen, MA for road resurfacing as their references checked out. The bid came in approximately \$400k less than expected so the City is now vetting nearby streets to resurface as well. For the crack sealing, Connecticut Seal Coating was recommended by the Committee since their overall price guarantee was the lowest. The Finance Committee also approved amending the contract with Credere who oversees environmental cleanup for the former Police Station. Their contract required an additional \$2,000. The Committee also discussed the Placework feasibility study for the library which should be considered to move to final design and the Committee recommended moving this project forward. Witham stated departments are all operating in the black and noted an upcoming retirement payout.

Public Works and Environment – Councilor Witham stated the Committee last met on February 1st. The Committee also discussed the road paving bids and Witham said there was further discussion surrounding a resident request to not shim and overlay Sinclair Avenue, but rather go through a reclamation process. It was determined by City Engineer Amber Hall that reclamation would make the project much more of an intensive process and the project would also need to rebid. The Committee unanimously supported the approval of PaveX Inc. for the road resurfacing projects and Connecticut Seal Coating for the seal coat projects. The Committee was also given an update by Manager Belmore of the ongoing and anticipated capital projects. The Committee also unanimously voted to NOT accept the grant for the hazardous mitigation engineering study on raising the Salmon Falls Road to address any future flooding of the road. The Committee felt there were more pressing issues to tackle first. Witham said the Committee discussed the request for a blue line down the middle of the road on Market Street and ultimately determined it would not conform with traffic safety regulations. Snow removal conditions were discussed in hopes to divert attention to higher traffic areas.

REPORT OF SPECIAL COMMITTEES, CITY OFFICERS AND CITY MANAGER

National Guard Building Reuse Commission – Councilor Witham stated the Commission last met on January 26th and heard proposals from SRPC on future use of the building and property. One reuse was to utilize the existing facility as a Community/Recreation Center, the second was to sell to a commercial endeavor (possibly a microbrewery), and a third use was a housing opportunity as a mix of single family and multi-family units. The plan to utilize the property as a Community Center would

cost the most, but not require any additional zoning. A commercial endeavor would require some zoning maneuvering, but would bring in sale and tax revenue. The sale of the property for housing would bring in the most cash flow to the City from initial sale and continued tax revenue. The Committee also had a discussion surrounding where the little league field could potentially be relocated to if the housing option was chosen. At a future meeting, it was decided to have SRPC come in for a City Council workshop. Witham also mentioned the City is currently in phase 2 of the environmental assessment on the property and has already found out what contaminants are present, but are now quantifying them.

COAST – Councilor Dumont stated the COAST Bus Committee met last on January 26th with a lot of discussion surrounding facility improvements and they have hired a fundraising consultant to assist them. Dumont reminded Council of their annual request of funding which will be happening again. He stated last year, the City gave COAST approximately \$80k and they will be requesting a little over \$96k for 2023. Dumont mentioned the strain Covid has put on COAST regarding staffing.

Unfinished Business (under Section 14 of Agenda)

Ordinance

- A. Ordinance No. 6-22: Supplemental Appropriation for the City's Share of a Grant Match for the Purchase of Police Department Body-Worn Cameras.** Again, the Finance Committee voted to support this Supplemental Appropriation.

Resolution

- A. Resolution No. 20-22: To Notify the City Tax Collector that the City Council Shall Not Accept a Tax Deed on Certain Properties Subject to an Unredeemed Tax Lien.** Again, the Finance voted to support Resolution No. 20-22 & Resolution No. 21-22 to the full Council.
- B. Resolution No. 21-22: To Notify the City Tax Collector that the City Council Shall Not Accept a Tax Deed on Properties Located on Wexford Lane and Blackwater Road Subject to an Unredeemed Tax Lien.** Again, the recommendation of 'not to accept' is based on the land containing buried debris; i.e., potential contamination clean-up costs.

New Business (under Section 15 of Agenda)

Ordinance

- A. Ordinance No. 7-22: To Amend Chapter 4, Personnel Rules & Regulations, Section 7.3 Holidays.** The Government Operations Committee met on January 24th and voted to support this Ordinance by adding Juneteenth Day (June 19) to the present list of Holidays for non-union personnel. Attached is a *red-line* version of the Ordinance with changes.

Manager Belmore requested a Public Hearing take place at the next scheduled City Council Meeting. Mayor Hilliard scheduled the Public Hearing at the next meeting without objection.

Other

- A. Vote to Adopt the City of Somersworth Updated Hazardous Mitigation Plan of 2021.** City Council needs to consider a vote on adopting this Updated Hazardous Mitigation Plan of 2021. SRPC will then coordinate with FEMA for final approval. I have attached a Memorandum from Fire Chief George Kramlinger that shows the process that was followed to update this Plan. Also, the Updated Plan has been added to your google dropbox.

City Manager's Items (under section 11 of Agenda)

Informational Items

- 1. City Parks/Ballfields Advertising Program.** Attached is an excerpt from City Ordinance, Ch. 30 regarding Conduct in Public Parks. The City Council had amended the Ordinance to allow the City Manager to develop an Advertising Sign Program. After discussions and review by the Recreation Committee, I issued the attached Administrative Regulation to set up a fee structure as well as certain standards and protocols. I have also attached a “*draft*” Lease & Maintenance Agreement in regards to the Little League continuing to operate on the former National Guard property that the City now owns. After reviews with both the Recreation Committee and the National Guard Building Reuse Commission, I intend to exempt the Little League from complying with this Administrative Regulation.

I was recently contacted by a Babe Ruth League representative to consider modifying this Advertising Program Administrative Regulation so that they, along with Somersworth High School Baseball Boosters, could begin a fundraising advertising program with more autonomy similar to the Little League (see attached). Without objection, I will finalize the Little League Agreement and inform the Babe Ruth League (Somersworth High School Baseball Boosters) that I will modify the City’s oversight and involvement of their Advertising Signage Fundraising Program similar to the Little League.

- 2. FY2022-2023 Geosyntec Contract Amendment for the Somersworth Landfill Superfund Site.** In keeping with past practice, and without objection, I will be signing the attached Draft Contract Amendment for proposed monitoring work to be done by Geosyntec Consultants as required by the EPA, this would cover FY 22/23. This Remedial Action Services contract outlines our compliance obligations in accordance with the existing EPA Consent Decree and Record of Decision (ROD) as well as other work that may be required by the EPA from time to time. The Contract costs and other associated budgeted expenses are split between the City at 50.5% and GE at 49.5%.

COMMENTS BY VISITORS

There were no closing comments from visitors.

CLOSING COMMENTS BY COUNCIL MEMBERS

Councilor Pepin said the warming center on Willand is a great thing that has been utilized frequently over the past couple months, but questioned the statistical data in CAP's reports. He outlined the differences in numbers of service calls to the warming center compared to what the City calculates and what CAP sends. Pepin said there are a lot of calls requesting police, fire, and ambulance going to the facility which is taking a significant amount of manpower and time away from the City's first responders. Pepin expressed concerns about the City's crime rates being skewed due to these calls which could ultimately end up negatively affecting the housing market in Somersworth.

Councilor Vincent stated the Lion's Club approached him about a possible donation of the metal building located on the former National Guard property. He said they would take it down and relocate it.

Councilor Dumont thanked Councilor Pepin for his remarks on the warming center. He acknowledged a disconnect from the reports coming from CAP and the numbers the City has. He stated the little league field is one of the more historic examples of construction for the benefit of children. He hopes at least a portion of that property can still be utilized for recreation. Dumont recommended extending the parking ban during emergency weather events.

Councilor Austin had no closing comments.

Councilor Michaud mentioned the Lion's Club skating rink and saw a video of a large number of kids utilizing the pond for hockey. He thanked them for doing a great job at keeping that property going. He congratulated Mark Segal, owner of Gravy, who celebrated his second anniversary in Somersworth. He also urged people to get out Anatolia Restaurant who serves delicious Mediterranean food.

Councilor Witham thanked Public Works for their snow removal efforts. He said the foreman said this past storm was the worst he has ever dealt with. He said when listening to his police scanner, he hears many calls going to the warming center. He stated CAP does not seem to be completely transparent in their reporting to the City and mentioned the initial weekly reports used to outline where the individuals utilizing the warming center were coming from, but do not anymore. Witham asked that at the conclusion of the season, a sum total of all the statistics the City Police, Fire, and ambulance have accumulated. He would then like to see a dollar number of what the calls of service have cost the City. Witham stated he fears the Council will find itself in a quagmire regarding what to do with the National Guard property. He said he hopes he is wrong, but thinks that property will remain urban blight in ten years.

Councilor Gerding thanked Public Works for their efforts during the difficult storm. Regarding the warming center, he wonders if there is a way to determine calls for service are actually increasing in the City due to the warming center, or rather, if they are just more concentrated at that location. Gerding mentioned the middle school in partnership with its advisory program and the ESL program are starting to create a black history month display and hopes it can be displayed at City Hall after its time at the middle school.

Councilor Cameron said the Lion's Club rink is a great thing and acts as a feeder program for kids wanting to play hockey for the school system. She hopes the little league field at the National Guard property stays when deciding the reuse of that property. Cameron also wished Mayor Hilliard a happy birthday.


Councilor Messier thanked a City Hall employee for his time working for the City and wished him well in his new endeavor. He stated he believes the National Guard property should be a Community, senior, or recreation center. He said a market analysis should be done to determine what is best for the City. Regarding the homeless, he said the residual effect of closing the Garabedian property has been moving south.

ADJOURNMENT

Councilor Michaud made a motion to adjourn the City Council meeting. The motion was seconded by Councilor Gerding and passed 9-0. The meeting adjourned at 8:39 p.m.
