ROLL CALL OF MEMBERS

The meeting was called to order at 7:00pm by His Honor, the Mayor, Dana S. Hilliard, and upon roll call the following Council members were present: Pepin, Vincent, Dumont, McCallion, Michaud, Witham, Sprague, Cameron, and Levasseur.

PLEDGE OF ALLEGIENCE

Councilor Pepin led the Pledge of Allegiance.

PUBLIC HEARINGS

Resolution No. 15-19 - To Approve a Bond to Provide Funding to Renovate Maple Wood Elementary School by Making Security Upgrades and Other Building Capital Improvements

No public comments.

Community Revitalization Tax Relief Incentive 79-E Application from Somedowntown LLC, property located at 57-65 High Street

David Baker, Portsmouth, owner of property, above Leroy's Barber Shop. His goal is to revitalize the downtown corridor, which he believes is undervalued and underutilized. His desire is to put 8 micro units in the building to provide a unique service to millennials. He wants to encourage business and activity in the community. He developed the Teatotaller, along with an executive apartment above and commercial rental space beside the Teatotaller. He plans for these new apartments to be move in ready; pay one fee for internet, utilities and water. He is still working on one small issue, parking.

COMMENTS BY VISITORS

A statement was read from Martha P. Carson, a homeowner of Curran Way. She requests that the City plow Curran Way.

Wade Penny, 9 Curran Way, stated that he has lived there for 12 years. There has been ongoing construction and general chaos the entire time. The city has received a petition to get the street accepted. He would like see that happen after all of the conditions and requirements are met. He requests that the process get moving. He would like to see things over and done with.

Leonard Tieszen, 29 Curran Way, one of the voices that would like to encourage the City to make life a little better for residents.

Stacy Woodley, 33 Curran Way, stated that she is concerned for road this winter. The biggest issue is safety of residents, guests, and school busses. She would not like to see an incident happen.

Alex Pena, 21 Curran Way, thanked the City and Council for all that has been done over the last several years. It is exciting to see what has been done in the City. There was almost an accident on Curran Way, 2 children were almost hit by a plow truck. Safety is the number one concern; children need to get to school and there are residents with health issues.

John Ambrose, 19 Curran Way, stated that he has lived there for 12 years, and he would like the City to take over the maintenance of the road. There was an occasion where a resident couldn't make it up the road. Several neighbors went out with snow blowers to clear the road. This is a very dangerous situation.

Brian Smith, 20 Curran Way, a retired veteran, has lived there for 10 years. He has daughters in the local schools, and buses are inconsistent; not sure what time the bus will show up. He has paid lots of tax money to the city. The plow situation on Curran Way is an issue. He would like to see the City move quicker for this to become a City Street.

Susan Plumber, 26 Curran Way, stated that she is concerned for the safety of the residents and children on the street. She has a daughter in the elementary school and one day the road was snow covered and the school bus refused to come up the street. They now have to walk their children to the end of the street. Having the City take the street over would be huge for safety.

Caroline, 25 Curran Way, requested that the City take care of the road in the winter. She has 3 kids and it is hard to take them to the school bus.

COMMUNICATIONS

City Council Meeting October 1, 2018 Presentation by Jen Czysz, Executive Director at Strafford Regional Planning Commission

Jen Czysz, Executive Director, and Colin Lentz, Regional Transportation Planner, presented an overview of the SRPC, stating that they cover are 18 communities in Strafford, Rockingham and Caroll counties.

Jen Czysz stated that the Regional Planning Commission is established under State Statute. It serves as an Economic Development District, which is a federal designation. They maintain and implement a comprehensive Economic Development Plan. Regional planning commission is comprised of the 18 communities, governed by the commissioners. There are 3 Commissioners from Somersworth. They meet quarterly, focus on things of general interest. There are three sub-committees; the executive, transportation tech advisory, regional impact committee. They provide general services to coordinate regional concerns; homelessness coalition for affordable housing options, as one example. They provide data resources, GIS services, mapping services, grant funding to priorities. The SRPC has done assessments for the Brownfields Grant for the Bretons Cleaners Property. They are also involved in assessments for the former police station property and the Hilltop School.

Colin Lentz explained under federal law, every urbanized area in the country above 50,000 in population is designated as a Metropolitan Planning Organization (MPO). There are several layers of programming for short, medium and long term projects. They were involved in a road safety audit at Blackwater and Old Dover Roads. An engineering review was conducted, which was part of a federally funded transportation alternatives project. Somersworth has applied for a phase 2 of the project.

The SRPC is also part of the CMAQ phasing of lights on High Street through Weeks Crossing. This is a medium range program. Somersworth has other projects on the preliminary list.

After the presentation, Councilors had the following questions.

Councilor Witham stated that this was a nice summary of what the SRPC has done for the City over the years. He is excited about the CMAQ project on High Street. The timing of the lights is poor. This council has opted to work with Dover in synchronizing through the intersection and onto Central Avenue. He asked about continuing the project the other way on High Street, into Berwick Maine. He asked if the CMAQ is limited by state borders. Lentz said he is not sure from the technical side, about crossing borders. Czysz stated that

it is possible to do cross state projects, but takes more coordination. The request and approval are location specific as opposed to funding specific. The project would need to be listed in both states. It is not impossible, just additional complexities.

Councilor Dumont said that there have been lots of studies for exit 10.

Colin stated that the exit 10 project is listed in the year 2022, many questions, as many things have changed. There is money programmed to look at the exit 10 situation.

Councilor Sprague asked about the 10 year highway plan and if they worked closely with legislators. As a state representative, he is a member of the Public Works and Highways Committee, and wants to do better at engaging the legislature.

Councilor Sprague went on to ask, what SRPC's stance is on shutting down one lane on Route 16 north bound for a pedestrian and bicycle lane. It is not helpful to anyone on this side of the bridge. Who discussed the data of those who use that bridge? There should have been something put on that bridge from the beginning.

Czysz stated that they as staff do not set the direction for the office. It is up to the commissioners and policy committee to make the policies, and so forth. What we will hear is the voice of the commissioners. Staff provides the technical information and advice.

Councilor Levasseur thanked Czysz and Lentz for the thorough presentation. He reiterated the comment about exit 10, stating that he doesn't know the specific timing from exit 10 to downtown. He also shared the sentiment that shutting down the lane is not a good idea, and will have negative impact on commute times.

Councilor Witham said that the most important step is communication. He encouraged the members of the SRPC to "please come more".

He is happy to see forward progress on Rt. 108, including up into Rochester. Exit 10 would benefit that area as well.

He stated that he was not aware of the details of the bridge project. He has seen a number of presentations about the tri city vitality; the choke point is the General Sullivan Bridge. Economic vitality will increase when that is relieved.

Councilor Dumont echoed the comments of others. Traffic seems to be getting worse heading south, to the other side of the bridge. In the afternoon, it is exacerbated by the construction. When the construction is completed, it will add to that flow. To shut down the lane, to accommodate 300 people, there must be a better solution.

Councilor Cameron said that traffic in that area is already bad, and to shut down a lane, then if there is an accident, she has already been delayed an hour and a half, and late for a meeting.

<u>Economic Development</u> – Councilor Dumont, reported that the committee met on September 18th, 2018. The committee discussed:

- 79e Tax relief application for 57-65 High St. project. There was lengthy discussion about the easement for parking. The committee recommended that the project go to full council.
- Form Based codes request for proposal
- RFP for Plaza parking lot, staff advised that they need to change their approach before going forward again.
- Former police station property, still presents challenges.
- They reviewed the Historic District Commission presentation, and will come before Council for acceptance.
- Chabots Dairy has a potential sale pending. There was discussion about the contingencies that were set for the previous owner, and if they have been completed.

Public Works & Environment Next Meeting is scheduled for October 10th, 2018 at 4pm.

REPORTS OF SPECIAL COMMITTEES, CITY OFFICERS AND CITY MANAGER

Special Committees

<u>Building Trades Trust</u> - Councilor Pepin reported that the treasurer of the trust has resigned, and that they are looking for a new treasurer. The committee is getting scarce on people. The whole program has changed over the years. They have built buildings that we are collecting taxes on. They supply equipment, and when the building is sold the money goes back into the fund. This has not been utilized over the past few years, because of shorter school periods, and having to transport the students on a bus. There was discussion to keep the trust open or use as scholarship money.

<u>Cultural Commission</u>, Councilor Dumont reported that the commission met on September 26th, 2018. The commission discussed:

- Cultural Events. There was not enough participation for the trip to Thedford Mines. They are going to look at a softer approach. They discussed ideas for the Museum to sponsor cultural events in the upcoming year.
- Discussion about a student exchange. They are discussing a trip in the spring to visit Thedford Mines.
- Wine tasting and chocolate evening. Councilor Cameron has made some headway with this event.

<u>COAST</u> – Councilor Dumont reported that the commission met on September 26th, 2018. The commission discussed:

• Has gone through a lot of changes over the length of time.

- Time delivery of services. They did some research and evaluations and realized that they were not delivering on a timely fashion. They have improved with the new system, and are continuing to monitor and make progress.
- Driver position is a difficult opportunity. There were 25 openings, have filled 20 since July.
- Website has been updated. They are now able to provide on demand services.
- Elected new leadership, those who are in position, remain in position.

<u>Sustainability Committee</u> – Councilor Levasseur reported that the Committee discussed:

- The handbook was very thorough, to address the makeup of the committee, projects for the year, etc.
- Draft plastic mitigation resolution was discussed and will be sent to the appropriate committees to be reviewed, then on to full Council.
- Looking at the Sustainability practices within the City from office supplies to large purchases.

<u>Historic District Commission</u> - Councilor Levasseur reported that the Commission met on September 26th, 2018. The commission discussed:

- 3 new business projects, all approved.
- 1 old business, project initially denied, because the commission did not have the proper information. The project is now approved.
- Elected officers for the current year.

Attached is a copy of Public Works Director Mike Bobinsky memorandum that points out Staff's concerns regarding the road's present condition and the need for a bond from the present development's (Sophie Lane, LLC) managing member, Joseph Caldarola. Director Mike Bobinsky and Director Shanna Saunders have been working with Mr. Caldarola for the past nine (9) months in an attempt to finalize the required acceptance criteria.

The State Agencies (Attorney General, Secretary of State and Department of Revenue Administration) have approved the proposed Charter Amendment as acceptable for City Council to consider moving it to ballot.

B. Vote to Approve the Community Revitalization Tax Relief Incentive (79-E) Application from Somedowntown LLC, Property Located at 57-65 High Street (under City Ordinance Chapter 31). The Economic Development Committee met on September 18th and voted to recommend acceptance of this application. Attached is a copy of the application from David Baker, Somedowntown LLC, as well as Director Saunder's memorandum determining the application is complete. I have also attached a sample covenant and the City Ordinance regarding this Tax Incentive Relief Program.

TO APPROVE A BOND TO PROVIDE FUNDING TO RENOVATE MAPLE WOOD ELEMENTARY SCHOOL BY MAKING SECURITY UPGRADES AND OTHER BUILDING CAPITAL IMPROVEMENTS

September 4, 2018

WHEREAS, the City Council of the City of Somersworth desires to renovate and make capital improvements to Maple Wood Elementary School by improving security, upgrading building functionality to include, BUT NOT BE LIMITED TO, upgrades to the original HVAC system, and to repair and replace the roof; and

WHEREAS, the project costs include architecture, engineering, construction, and any other ancillary costs associated with the project; and

WHEREAS, the School Department has been notified that they have been awarded a \$720,000 (Seven Hundred Twenty Thousand dollar) grant from the Public School Infrastructure Fund to support the security improvements;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOMERSWORTH THAT an amount not to exceed \$2,360,000 (Two Million Three Hundred Sixty Thousand dollars) is appropriated to renovate and make improvements to Maple Wood Elementary School by improving security, upgrading building functionality to include, BUT NOT BE LIMITED TO, upgrades to the original HVAC system, and to repair and replace the roof; and

BE IT FURTHER RESOLVED THAT:

- (a.) the City Manager is authorized to borrow up to \$1,640,000 (One Million Six Hundred Forty Thousand dollars) under the Municipal Finance Act and issue bonds and notes payable within 15 years from their dates,
- (b.) the City Manager is authorized to issue temporary notes in anticipation of the issue of these bonds or notes,
- (c.) the City Manager is authorized to apply for, obtain and accept federal, state or other aid, if any, which may be available for said project,
- (d.) the estimated useful life of this project is expected to exceed 15 years.

Discussion

Councilor Witham, seconded by Councilor Pepin, made a motion to adopt Resolution 15-19, as amended. The motion passed, 9-0.



WHEREAS, the School Building, Grounds, and Transportation Committee reviewed the bids received and recommends contracting with Ideal Temp HVAC of Freemont, NH to replace the HVAC unit utilizing funds available from an Eversource energy efficiency incentive rebate, and

WHEREAS, the Finance Committee met with the school administration and supports this recommendation at a cost not to exceed \$30,000 (Thirty Thousand dollars),

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOMERSWORTH THAT the School Department is authorized to contract with Ideal Temp HVAC of Freemont, NH to replace an HVAC unit at the Somersworth Middle School at a cost not to exceed \$30,000 (Thirty Thousand dollars), and

BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOMERSWORTH THAT the School Department is authorized to use the Eversource energy efficiency rebate to fund this project.

Note: The School Department received \$75,000 from Eversource as an incentive for implementing certain energy efficient projects at Idlehurst Elementary School. There is currently \$33,373 left from this incentive.

Councilor Witham, seconded by Councilor Sprague, made a motion to suspend Council rules to allow for a second read of Resolution 19-19. The motion passed unanimously, 9-0. Following the Second read, Councilor Witham, seconded by Councilor Levasseur, made a motion to adopt to adopt Resolution 19-19.

Discussion-

Councilor Witham explained that a street cannot be accepted as a City street until the developer is completed with the proposed number of homes. This is the first time that this street has been addressed to the council. In this case, it has taken quite a bit of time for the street to come to full build out.

There has been some discussion about the integrity of the asphalt.

Councilor Witham, seconded by Councilor Vincent, made a motion to suspend rules to allow DPU Director Bobinsky to come up for questions. The motion passed, 9-0.

Councilor Witham stated that he read the memo from Director Bobinsky. There is some cracking on the road, recognized by city staff. The road was built to city specifications, and there has been degradation of the surface.

Director Bobinsky said there were boring samples of the road to test the compaction and density; they tested positive. The cracking was brought to the attention of the developer. The final suggestion was to allow him to fill the cracks, and create a uniformed cover by repaving the road. The developer will post a 2 year bond.

Councilor Sprague asked if, in 2007, were there compaction tests, on base gravel. There needs to be a better procedure for informing residence that the road is not a city road, or maintained by the city before they purchase property; maybe a sign, like other communities have.

Director Bobinsky said that the compaction tests do not stand out in his mind. There is a 1" base, and a 1 ½" top. The curbing is ok, and there is no substantial cracking on the upper end.

Councilor Witham said he called for a second read of this Resolution for the discussion to occur tonight for the people who live on Curran Way and spoke. We need to look out for the community as a whole. He would like to see this discuss at the Public Works and Environment committee.

Councilor Dumont spoke about the safety and lack of attention for danger for children. The road is prepared and accepted before the first certificate of Certificate of Occupancy is granted in other communities. If a developer is not providing the information to new residents, there is a flaw in our process.

Pepin thanked the citizens of Curran Way for showing up and for taking care of their neighbors. His main concern is that he doesn't want to accept another road that we have problems with. The base is good, need to address the crack problems.

Councilor Sprague said the cracking at the entrance of Curran Way is due to stretching, which is due to the heavy trucks entering and exiting. Without knowing specifications, he is not going to vote on this tonight. Would like it to go to the Public Works and Environment Committee for further discussion.

Councilor McCallion, seconded by Councilor Levasseur, motion to TABLE Resolution 19-19. The motion passed unanimously, 9-0.

OTHER

- A. Vote to place the proposed Charter Amendment question on the ballot for a Special Municipal Election on November 6, 2018
 - The Vote passed, unanimously, 9-0.
- B. Community Revitalization Tax Relief Incentive 79-E Application from Somedowntown LLC, property located at 57-65 High Street

Councilor Levasseur stated that the work Mr. Baker has done on the Teatotaller building is impressive. He believes accepting the application is the right move. He will vote to approve.

Councilor Witham said he agrees with Councilor Levasseur. We have seen evidence of what this developer can do. It is a Public benefit for a vibrant downtown, encouraging foot traffic and residents in the downtown area. It is in line with the city's master plan for a walkable community. One thing to contemplate is the 7 years of tax relief and the overall condition of the property. Many other properties have been in a significant state of disrepair.

Councilor Sprague said he is on the committee and it is premature to discuss this 79e at this point. There are a lot of the numbers are contingent upon many things. This may not be started until a year from now. He is requesting a variance for parking. If it is not approved and there is not parking lot, he would like to know what the numbers will be.

Councilor McCallion said that we've seen what he can do, and I am sure he has done his due diligence. He would like to see a number that we are losing or gaining in the last 2 additional years.

Councilor Sprague stated that the numbers will change depending on the number of parking spaces. Nobody knows what the construction costs will be.

Councilor Levasseur said we need to change the way we thing about parking. Speaking from being the type of person that the developer is trying to attract, he works from home and doesn't have to travel. We are getting caught up in the 5 and 2 years. We've seen the work that this gentleman can do. He is in favor of supporting this tax relief.

Councilor Dumont said that he agrees that this developer has a history of improving the downtown. This developer spent the time and the money for the proposal, and anticipated reconsiderations for variances. There is an element of risk, but the largest risk lies with the developer. He has a forward thinking project. We cannot rely on past to dictate the future. It takes somebody who is willing to take an amount of risk. He is in favor of supporting this tax relief. He stated that it is hard to believe that the number

of parking spots will dictate the future. More than just money, there is a vision, a gut feeling and a belief that this community can rise to the top.

Councilor Pepin stated that Mr. Baker came to the committee recently, about another property. With that property, Mr. Baker said that he would not be able to renovate that property for some time based on other projects and financing. He needs to know if the city is going to grant the 79e to know if he can afford to do the property. Councilor Pepin said he will support the tax relief.

Councilor Cameron said Mr. Baker brought vision to the community and revitalization to the downtown. She will support the tax relief.

Councilor Witham, seconded by Councilor Dumont, made a motion to grant 79e tax relief to Somedowntown LLC, for a period of 7 years. The motion passed 8-1, with Councilor Sprague opposed.

CLOSING COMMENTS BY VISITORS

Josh Ambrose of Curran Way thanked the Council for waiving the rules to have the discussion regarding Curran way this evening while the residents were at the meeting. He understands further conversation needs to happen.

CLOSING COMMENTS BY COUNCIL MEMBERS

Councilor Pepin thanked all who were involved in the Talking Tombstones; complements to all.

Councilor Vincent said that the Lions Club will be in the schools doing eye screening in the next few weeks. He recently went by the West High Street culvert project. He was a bit concerned with the cost of \$49k. He was not familiar with this process, so he educated himself. The project looks great and he found that it was not a bad price, he was happy about.

Councilor Dumont said grieves and will pray for the people of Indonesia; a challenged culture. We appreciate and support those in our community.

He shared his concern for scam calls to the elderly, especially where some have been threatened to go to jail.

Congratulations to the Somersworth High School football team.

Councilor Witham stated that he was happy to see the City's newly acquired street sweeper sweeping its way through town. He shared his concern for the litter of bags and flower pots along the side of the road on High Street. It looks like someone may have lost their purchases as they pulled out of Home Depot.

He also checked out the culvert on West High Street and is happy with the progress.

City Council Meeting October 1, 2018 He spent some time looking over materials from the HDC workshop; the ordinance revision is to make it easier on homeowners to do repairs and retain the integrity. He would like to better understand that process.

He saw in the International City Manager Publication, our City Manager Bob Belmore was recognized for 40 years to Municipal government.

Councilor Sprague stated that the culvert on West High Street could have done cheaper, but not in the time frame that was required.

The Public Works and Environment Committee will be meeting in the Executive Conference room at 4:00 on Oct 10th. On the agenda is Curran Way. He encouraged residents to attend.

He wished Mr. Baker good luck with the project, stating that he is for the project, but should remember that Somersworth is a walkable community, not everyone will need a car.

SRPC talked about the Rt. 108 corridor. He was recently in Freeport, Maine on Rt. 1. The turning median made you go slower. City staff should take a trip up there and see what they have.

Councilor Cameron said she attended the Talking Tombstones. It was a wonderful event. She found the tombstone of friend, John Valentine. She reminded the community that the Pumpkin fest on the 13th.

Councilor Levasseur stated that he has recently moved to 155 High Street. He still enjoys the amenities in the downtown area. He would like an update on the solar project on the Blackwater site. He would also like an update on the yield signs that were agreed upon in the downtown corridor. If we are going to be a walkable community, need to be about it.

Councilor Michaud, seconded by Councilor Pepin, made a motion to adjourn. The meeting adjourned at 9:27 pm.
