

### ROLL CALL OF MEMBERS

The meeting was called to order at 7:00pm by His Honor, the Mayor, Dana S. Hilliard, and upon roll call the following Council members were present: Pepin, Vincent, Dumont, Austin, Michaud, Witham, Gerding, Cameron, and Paradis.

## PUBLIC HEARINGS

**Ordinance No. 15-20** - To Amend Chapter 12, Streets and Sidewalks No Comments

**CDBG** – Public Hearing on the Proposed Project – Somersworth Housing Authority's Improvements

Donna Lane, CDBG Consultant, stated that the Community Development Block Grant funds are available to municipalities through the NH Community Development Finance Authority. Up to \$500,000 annually is available for economic development projects, up to \$500,000 for public facility projects, up to \$500,000 for housing projects, and up to \$500,000 for emergency activities. Additionally, up to \$25,000 is available per planning/feasibility study grant. All projects must directly benefit a majority of low-and moderate-income persons.

The purpose of this hearing is a proposed application to the Community Development Finance Authority for up to \$500,000 in Community Development Block Grant Housing Grant. The City will retain up to \$25,000 for administrative expenses and grant the bulk of the funds to the Somersworth Housing Authority (SHA). SHA will then loan the CDBG funds to a related entity to be determined to complete facility upgrades; including replacement windows to Somersworth Housing Authority's Albert J. Nadeau Homes located on Bartlett Ave & Verona Street as well as Filion Terrace located on Washington Street; in addition the replacement of apartment doors at Filion Terrace and Charpentier Apartments, located at 28 Franklin Street in Somersworth, NH. All 169 units are occupied by low- and moderate-income households.

This project conforms with Somersworth's Housing and Community Development Plan's Goal of: Encourage a varied stock of safe, sanitary, decent and affordable housing for persons of all age and income groups. Increase and improve housing through renovation and/or rehabilitation of existing structures and through new development. (Short-term goal and long-term goal) Information packets were available for public review.

The Public was asked for comments. With there being no further comments, Mayor Hilliard closed the Public Hearing.

**CDBG** – Public Hearing on the Housing and Community Development Plan

Donna Lane, CDBG Consultant, stated that the Housing and Community Plan outlines long term and short term goals for the City and needs to be readopted every 3 years. The City of Somersworth's three-year short and long-term goals and objectives are as follows:

Goal: Encourage a varied stock of safe, sanitary, decent and affordable housing for persons of all age and income groups

Goal: Encourage economic development activities to increase quality industrial and commercial development

Goal: Encourage the protection, enhancement and renovation of significant historic and architectural resources in the community. Preserve and promote the town's historically and culturally significant

structures.

Goal: Encourage municipal and private water and wastewater systems that are safe, sanitary and that meet DES regulations. (Short-term and long-term goal).

Goal: Promote activities that protect the health and safety of residents and visitors

Information packets were available for public review.

The Public was asked for comments. With there being no further comments, Mayor Hilliard closed the Public Hearing.

**CDBG** – Public Hearing on Residential Antidisplacement and Relocation Assistance Plan Donna Lane, CDBG Consultant, stated that this Plan states in general, that if the City were to undertake a CDBG project which involved displacement and resulting relocation they would follow the Uniform Relocation Act requirements. The Residential Antidisplacement and Relocation Assistance Plan outlines the measures they would take to find comparable, housing for persons (or businesses) displaced and/or relocated.

This project will require some temporary relocation. Residents will be relocated to empty units on site, to modular units on site, or to other properties owned by SHA. SHA will pay temporary relocation costs for eligible households.

Information packets were available for public review.

The Public was asked for comments. With there being no further comments, Mayor Hilliard closed the Public Hearing.

## Special Committees

COAST – Councilor Pepin reported that they are still working on the CMAQ grant.

Planning Board – Councilor Witham reported that there was a Compliance Hearing for Cumberland Farms on Rt 108, in December, regarding the deterioration of Blackwater Road, which has been observed by staff and residents. This is caused by the tanker trucks and vehicles passing to turn. Cumberland Farms agreed to pave a 4' shoulder on both sides of the road. This will take place in the spring. The City will oversee the project. There was discussion about other concerns with signage and dead vegetation. They were receptive and are moving forward.

Veterans Park Commission – Councilor Dumont reported that there were 2 benches available. He was happy to announce that both have been sponsored for \$2,000 each. The State of New Hampshire Catholic War Vets each donated \$1000 each. Hilltop Chevy donated \$100 from the sale of every car between Veterans Day to December 31<sup>st</sup>. They had a banner sale during that time. We are still waiting for the total amount. We now have a

second opportunity to remember a loved one who have served. Bricks are a \$50 donation each. We will be getting the bricks from the same company that did the bricks in Dover. We will also have 16 granite pavers available for a \$1500 donation. The ground breaking ceremony will be Memorial Day 2020. New Councilor, Matt Gerding also donated campaign funds to the to the Veterans Park.

These changes are intended to add clarity to certain sections of the Ordinance. Again, the Public Works & Environment Committee voted at their November 14<sup>th</sup> meeting to support this Ordinance change.

## **Resolutions**

A. Resolution No. 22-20: To Authorize the City Manager to Sign an Application for a Community Development Block Grant (CDBG) to Upgrade the Windows at the Albert J. Nadeau Homes and Filion Terrace, and Replace Apartment Doors at Filion Terrace and Charpentier Apartments, and to Sign the Adopted 2020 City Housing and Community Development Plan and 2020 Residential Antidisplacement and Relocation Assistance Plan. Again, the Finance Committee met on November 26<sup>th</sup> and voted to support this Resolution. Somersworth Housing Authority (SHA) is looking for approval from the City Council to apply for CDBG funds as the City would act as a sub-recipient of the grant request totaling \$500,000. The City Council will need to adopt the Housing Relocation and Community Development Plan as this is an application requirement in order for this Grant project to move forward. Attached are copies of the proposed plans.

**B. Resolution No. 23-20:** Proclaiming Somersworth a Welcoming City. This Resolution has been referred by Mayor Hilliard to the Government Operations Committee.



City of Somersworth – Ordinance

Ordinance No: 15-20

## TO AMEND CHAPTER 12, STREETS AND SIDEWALKS

December 16, 2019

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SOMERSWORTH THAT the Ordinances of the City of Somersworth, as amended, be further amended as follows:

Delete Chapter 12, Streets and Sidewalks in its entirety, and replace with the following:

### CHAPTER 12 STREETS AND SIDEWALKS

SECTION 12.1 - Excavate, Obstruct or Encumber

PERMIT REQUIRED: No person, firm or corporation, or any agent or servant thereof, shall excavate, obstruct, or in any way encumber any street, sidewalk or other City-owned property or right-of-way in the City of Somersworth without first having obtained a written permit to do so from the Director of Public Works, or designee, except where such licensing power is particularly vested in the City Council (see RSA 231:184). Any person, persons, firm or corporation violating any of the provisions of this section shall be fined not less than \$500.00 nor more than \$1,000.00 for each violation, pay for any repairs necessary to bring the trench into compliance, and may subject the Permittee/contractor to revoked digging privileges.

EXCEPTION, PER RSA 236:9: The exception to the above shall be in cases of emergency where the public health or safety is endangered. Such immediate action as may be necessary may be taken without such permission, but in such cases the person directing or taking such action shall at once notify the Director of Public Works, or designee.

REGULATIONS: Permittees shall obtain a copy of and adhere to all provisions of the Somersworth Construction Standards by the Department of Public Works and Utilities.

WORK SCHEDULE: Except for emergencies as may be deemed essential by the Department of Public Works and Utilities, no person, firm or corporation or any agent or servant thereof, shall excavate, obstruct, or in any way encumber any street, sidewalk, or other City-owned property or right-of-way in the City of Somersworth between the 15<sup>th</sup> of November and the 15<sup>th</sup> of April. The Director of Public Works, or designee, must approve the schedule of work. Scheduling will be such as to not unreasonably interfere with traffic.

FEES: Every permit will require the Permittee to pay a fee to the City to cover the City's cost of reviewing, processing, inspecting, and executing the permit. The amount of the fee will be established by the Department of Public Works and Utilities.

BONDS AND LETTERS OF CREDIT: Every Permittee will be required to furnish one of the following:

- Bonds Permittees who regularly work in the City can opt to provide an annual bond to the City, with the approval of the City Engineer. The amount of the bond will be established by the Department of Public Works and Utilities.
- Letters of Credit Permittees who regularly work in the City can opt to provide a Letter of Credit from a New Hampshire bank to the City, with the approval of the City Engineer. The amount of the Letter of Credit will be established by the Department of Public Works and Utilities.

BACKFILLING, PAVING, DUST CONTROL, AND TRAFFIC CONTROL: These items will be done in accordance with the Somersworth Construction Standards.

INSPECTIONS: The Director of Public Works and Utilities or his/her designee may inspect the site prior to the commencement of backfill, during the backfill operation, prior to the commencement of paving and during the paving operation. It shall be the responsibility of the licensee to arrange for these inspections during normal working hours, and he/she shall provide a 24-hour notice.

MORATORIUM PERIOD: In an effort to protect the City's investment in its infrastructure, excavations in newly constructed, reconstructed, rehabilitated, or overlaid pavements anywhere within the public right-of-way or on City property, to include streets and sidewalks, are prohibited as follows:

- For pavements that have been overlayed, the excavation moratorium shall be three (3) years after the effective date of completion or acceptance.
- For pavements that have been reclaimed, reconstructed, rehabilitated, or are newly constructed, the moratorium period shall be five (5) years after the effective date of completion or acceptance.

INSURANCE: As a condition of this permit, the Permittee shall agree to provide insurance to indemnify the City of Somersworth and the Department of Public Works and Utilities, including all officials and employees thereof. Required policies shall include, but not be

limited to. Comprehensive General Liability and Workman's Compensation. The requirements of the policies will be according to the Somersworth Construction Standards.

REVOCATION OF PERMIT: The City of Somersworth, Department of Public Works and Utilities, or the City Engineer may revoke any permit issued under this regulation at any time.

Section 12.2 - Use of Sidewalks

No person shall drive any vehicle or equipment on any sidewalk in the City, except for strollers, wagons, carriages, or other methods of transporting small children.

Section 12.3 - Signs and Awnings

No person shall place, establish or maintain any sign, awning or shade before his/her place of business, dwelling house or tenement, over any part of any street or sidewalk, unless the same be safely fixed and supported so as in no way to incommode or endanger persons passing upon such street or sidewalk and so that the lowest part of such sign, awning or shade shall be at least seven and one-half feet above the sidewalk; nor shall any person hang, affix, fasten, place or allow to remain upon the outer edge of any sidewalk, any sign or showcase except in conformance with the requirements of the Zoning Ordinance. (Amended 7/18/1994.)

Section 12.4 - Rubbish, Refuse and Garbage

(See Chapter 7 - STREETS, SIDEWALKS, SEWERS).

Section 12.5 - Snow and Ice

- No person shall deposit, or cause to be deposited, any ice or snow that has been removed from private property in or upon any street, sidewalk or public place in the City, nor shall such snow or ice be put or placed in a public road so as to block access to hydrants or sidewalks maintained by the City during snow events.
- 2) No person shall deposit, or cause to be deposited, including, but not limited to deposits from roof and/or foundation drains/pumps, any liquid from private property in or upon any public road, sidewalk, or City property, in such a manner so as to cause a condition hazardous to pedestrian movements and/or to the normal and reasonable flow of vehicle traffic.

Section 12.6 - Transporting Buildings

No person shall move, or assist in moving, any house, shop, or other building through any street, lane or alley, without first obtaining a written license therefore in the manner prescribed in Section 1 of this chapter.

When the City Engineer shall, as aforesaid, grant permission to any person, firm or corporation, to encumber any street sidewalk or public square, for the purpose of erecting, altering or moving buildings, or to dig up or encumber the same in any other manner, he may, as a condition to granting such permission, require the party obtaining the same to furnish a bond of indemnity to the City of Somersworth in such sum and with such sureties as he may deem proper.

Section 12.7 - Driveways

PERMIT REQUIRED: It shall be unlawful to construct, or alter in any way that substantially affects the side or grade of, any driveway, entrance, exit, or approach within the limits of any street, sidewalk or other City-owned property or right-of-way in the City of Somersworth without first having obtained a written permit to do so from the Director of Public Works and Utilities, or designee, except where such licensing power is particularly vested in the City Council (see RSA 236:13). Any person, persons, firm or corporation violating any of the provisions of this section shall be fined not less than \$500.00 or more than \$1,000.00 for each violation, pay any late fees as part of an after-the-fact the permit application, and pay for any repairs the City deems necessary.

**REGULATIONS:** Permittees shall obtain a copy of and adhere to all provisions of the Somersworth Construction Standards by the Department of Public Works and Utilities.

FEES: Every permit will require the Permittee to pay a fee to the City to cover the City's cost of reviewing, processing, inspecting, and executing the permit. The amount of the fee will be established by the Department of Public Works and Utilities.

Section 12.10 The Director of Public Works and Utilities, or designee, shall issue permits in accordance with rules and regulations promulgated by the Planning Board. June 6, 1972.

Councilor Vincent stated that the urgency for the second reading is for the situation at hand. This has been ditched by the Attorney General and it's like this has been buried. He is in favor of moving forward.

Councilor Witham stated, as Councilor Vincent said, the Attorney General has ditched this; it has hit a road block. Why is that?

## Councilor Witham, seconded by Councilor Austin, to waive council rules to allow Ben Bradley, Director of Government Relations and Public Policy of Wentworth Douglas, to address the council. Motion passed, 9-0.

Mr. Bradley said that the process through the state is two-fold. One is through the Division of Charitable Trusts which reviews our charitable mission as non-profit hospitals, ensuring that we maintain our mission for providing access to addressing the physical and mental health needs of the community. And secondly to ensure that the Attorney General doesn't find any antitrust concerns. The issue that we ran into is around antitrust concerns. The Attorney General offered an objection to the affiliation in September. They happen to disagree with the Attorney General assessment and hope to work with him to move this affiliation forward.

Councilor Witham asked what antitrust is, in laymans terms.

Mr. Bradley said they feel the marketing analysis was not appropriately done, as they did not include Frisbee Hospital and others in the area.

Councilor Vincent said he has been very involved with this in the State level; he has received lots of emails. The Attorney General is concerned that there would be a conglomerate take over. He asked if the AG has closed the case.

Mr. Bradley stated that the Attorney General has offered to meet in the near future.

Councilor Witham said Wentworth Douglas has affiliation with Mass General, and he assumes there was not issue at that time. This is to affiliate with Exeter, correct? Mr. Bradley said that is correct. Councilor Pepin said this is a no brainer. He lost an infant many years ago. They talked about being able to bring the child to Boston then. He said he can't believe that we still don't have an area around here. As for substance abuse and mental health, being on emergency response, just the time and money that is involved, it is a no brainer. He just hopes that it goes through.

Councilor Gerding said it is his understanding that Frisbee Hospital is looking to join with Portsmouth Regional Hospital. It is interesting that they were left out of the AGs report. It seems like Exeter would be the one left out.

Councilor Paradis stated that she went to a forum on the Frisbee sale and it is important to note that these three entities are non-profit. The \$13million for the mental health and substance abuse disorder will not be going directly to Exeter; it will be split across with Wentworth Douglas and Massachusetts General. She asked if there were any guidelines as to ho they would choose partners to deliver those services.

Mr. Bradley stated that they have great partnerships in the communities already and they would hope to continue those partnerships and make investments where appropriate. They are looking at primary care and other areas. Also looking into capital improvements that would provide greater access to ensure people aren't visiting the emergency department in those crisis situations, but getting treatment early.

Councilor Dumont stated that in the last 20 years, health care in the area has improved. Thank God we do what we do currently. It doesn't make sense that someone would not consider this. Remember the days when Frisbee and Wentworth Douglas were close to becoming one. Wentworth Douglas became the entity that could deliver more services. People travel to Wentworth Douglas for their oncology center. Whoever is standing in the way is not interested in quality care.

Councilor Witham asked if we adopt this resolution, will this be communicated to the state?

City Manager Belmore said yes. It will be sent to the Governor and to the Attorney General.
